1. Introduction

Softgarden is committed to ensuring digital accessibility for all users, including those with disabilities. We are actively working to increase the accessibility and usability of our products and adhere to the **Web Content Accessibility Guidelines (WCAG) 2.1** Level AA, developed by the World Wide Web Consortium (W3C).

1.1. Key Principles of Accessibility

Our accessibility efforts are guided by the four foundational principles of WCAG:

- **Perceivability:** Information and user interface components must be presented in ways users can perceive.
- **Operability:** User interface components and navigation must be operable by all users, including those using assistive technologies.
- **Understandability:** Information and the operation of the user interface must be understandable.
- **Robustness:** Content must be robust enough to be interpreted reliably by a wide variety of user agents, including assistive technologies.

2.2.1. Applicant-facing product offering

With **June 28, 2025** we ensure full compliance with WCAG 2.1 Level AA for all applicant-facing software.

However, a minimum level of accessibility is being ensured through limited support for essential features such as keyboard navigation and ARIA attributes.
Career Site Pro – Page Builder	-	As a content authoring tool, the visual Page Builder of the Career Site Pro is not required to fully conform to WCAG standards. However, a minimum level of accessibility is being ensured through limited support for essential features such as keyboard navigation and ARIA attributes.
Referral Manager – Admin Interface	-	Currently not compliant. Softgarden is working on this throughout 2025.
Agency Solution	-	Currently not compliant. Softgarden is working on this throughout 2025.
